

**“HYGIENE AND SANITATION IN MEAT AND POULTRY HANDLERS

Commissioner, JMC conducts the tour of Ward No. 38.

The Commissioner, Jammu Municipal Corporation, Ms. Avny Lavasa (IAS) conducted the tour of Ward No. 38 accompanied by the concerned Officers of JMC alongwith concerned Councillor, Sh. Surinder Sharma during the tour, the Commissioner visited areas where the nallah flowing from Basant Nagar to Paloura requires renovation and lanes of Pamposh Colony Janipur at sectors 2, 3 & 4 require black topping. The Commissioner, JMC directed the Executive Engineer concerned for preparing the estimates for the same so that the issues can be resolved at the earliest which will help to mitigate the problems of the residents of the ward.

The residents of the ward appreciated the Commissioner, JMC for conducting tour of their ward and also to listen their grievances patiently and residents assured that they shall provide full cooperation to Jammu Municipal Corporation for better well being of the ward.

The Commissioner, JMC further appealed to all residents of the city to come forward and join hands with Jammu Municipal Corporation so that we can jointly work for making our city no. 1 in respect of sanitation scenario and also avoid using of polythene carry bags and throwing of C&D waste into nallahs which is a major cause of choking of nallahs resulting into sufferings for the residents.

General House of Jammu Municipal Corporation for discussion and adoption of Unified Building Bye Laws

A special session of the General House of Jammu Municipal Corporation for discussion and adoption of Unified Building Bye Laws-2021 was held on 20-12-2021 in the Council Hall of Corporation under the Chairmanship of Hon'ble Mayor Sh. Chander Mohan Gupta. The session was attended by Deputy Mayor, Hon'ble Councillors, Commissioner JMC and other senior Officers of Jammu Municipal Corporation and other line departments.

Threadbare discussion on various provisions of Unified Building Bye Laws – 2021 happened during the special session of the House. Hon'ble Councillors suggested some modification / amendments in the Unified Building Bye Laws – 2021. To address the issues raised by some of the Councillors, Hon'ble Mayor announced the constitution of a committee under the Chairpersonship of Deputy Mayor which will submit a comprehensive report regarding modification / amendments to the Unified Building Bye Laws – 2021 document. The committee will submit the report within a week's time.

Later the House of Corporation adopted the Unified Building Bye Laws-2021 with the deliberations that the amendments required in these Bye laws submitted & finalized by the committee constituted shall be forwarded to the Government for inclusion of these amendments in the Unified Bye Laws - 2021.

The House also discussed various issues pertaining to PWD (R&B) Department. Chief Engineer, PWD (R&B) Department assured the House that the issues would be resolved at the earliest.

Commissioner, JMC inspects ongoing constructions.

The Commissioner, Jammu Municipal Corporation, Ms. Avny Lavasa (IAS) carried out the inspection of ongoing construction for which the permission of stage-II Commercial/residential accorded by Jammu Municipal Corporation for verifying that constructions raised at site is as per approved building plan. The areas visited include Akhnoor road, Muthi, Paloura, Akalpur area and Bantalab area. The Commissioner, JMC issued instruction to the Enforcement Staff to keep a strict vigil on all the ongoing constructions to avoid any violation.

She further stated that citizens should obtain proper permission from Jammu Municipal Corporation before undertaking construction, as unauthorized/illegal construction shall lead to sealing/dismantling of the same because JMC shall not tolerate any violation in respect of Master Plan-2032 and added that JMC has introduced new Online Building Permission System which is citizen friendly and very easy way to obtain building permission at their door steps.

The Commissioner appealed to general public to avoid undertaking illegal constructions residential as well as commercial as JMC has made everything easy and smooth for undertaking constructions legally and citizens should follow the proper guidelines for the same.

During the inspection Anil Raina, Chief Town Planner, JMC and other staff of Building Section also accompanied the Commissioner, JMC.

Sanitation Drive launched by JMC

JMC in its continuous efforts to ensure sanitation in Jammu City, has launched a special sanitation drive as per the directions of Commissioner, Jammu Municipal Corporation in Narwal Highway, Jammu. The sanitation drive was started from Narwal Chowk and covered most of the areas from sanitation point of view. During the drive the Health Officer interacted with shopkeepers and other business establishments and aware them about user charges and added that every business establishments should keep dustbins so that the same can be lifted properly by the JMC. The aim of launching this special sanitation drive is to cover most areas of Narwal and aware the shopkeepers about the importance of SBM. During this a dedicated team comprising of concerned Sanitation Officer, Sanitary Inspector/Sanitary Supervisor and other allied staff was put in place under overall supervision of Health Officer, JMC. The Commissioner, JMC have already directed the sanitation staff for putting their every possible effort for providing proper sanitation to the citizens of entire Jammu City so that no area should be left untouched in respect of sanitation as the sanitation is main mandate of JMC and main focus should be on sanitation.

She further appealed to the shopkeepers of Narwal area as well as general public to cooperate with Jammu Municipal Corporation and use identified places for disposal of garbage. She also stressed to avoid use of polythene to the extent possible which is the major cause of blockage of drains and nallahs. She stressed for putting every possible efforts in achieving goal of making city Jammu Clean & Green and aim of Swachh Bharat Mission and added that such type of special drives shall continue in future to cover every nook and corner of the city from sanitation point of view.
