Pursuant to the directions given by Hon'ble Chief Minister, J&K, Jammu Municipal Corporation and under able guidance of Commissioner, JMC Ms. Mandeep Kaur, IAS and under supervision of Ms. Subah Mehta, KAS, Asstt. Commissioner (Revenue), JMC has created street vending zones in different areas to decongest the city markets, Chowks, bus stands and other places where traffic congestion is a routine feature.

According to the number of Rehris in different areas like Bikram Chowk, Panjtirthi, Parade, Bus stand, B C Road, Janipur and many other places where traffic jams are every day's menace, creation of these Street vending Zones will not only ease traffic but will also help in facilitating business by these street vendors who every day suffer from dislocation and harassment by enforcement agencies. These zones will give them a fixed place to do their business. It will also take care of sanitation issues of the places where these Rehris used to be parked earlier as JMC will collect all organic waste from these zones for composting.

41 such locations have been identified so far across different wards of JMC and gradual shifting of Street vendors has started in 4 Rehri Zones in cooperation with District and Traffic police.

Jammu Municipal Corporation appeals to all the Rehri owners to carry out their business in Rehri Zones identified by Jammu Municipal Corporation to earn their livelihood in dignified way and no one will be allowed to harass them if they do their business in a prescribed manner and if any Rehri found plying/stationed outside Rehri zones stern action shall be taken against the defaulters which will also include confiscating their rehris at their own risk and cost.

Instructions were issued to the Engineering division to complete the balance works within the shortest possible time.

# <u>Town Vending Committee constituted for establishment of Rehri</u> <u>Zones in Jammu</u>

Pursuant to the directions of Hon'ble Chief Minister of the state, Mrs. Mehbooba Mufti, 47 Rehri zones have been established in the Jammu municipal corporation area. Process of shifting all street vendors to these zones is on and so far 10 zones have been made operational. In order to motivate and involve the relevant stakeholders in the process, Commissioner, Jammu Municipal Corporation Ms. Mandeep Kaur (IAS) called the first meeting of Town Vending Committee constituted under the "Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act., 2014" today on 16.06.2016 in the meeting hall of Jammu Municipal Corporation. Its pertinent to mention here that National Policy on Urban Vendors (2009) of Govt. of India and further directions of the Hon'ble Supreme Court require every city to have an earmarked zones for street vendors with basic civi amenities, so that they may have honrable living.

During the meeting issues related to rehabilitation of street vendors/ rehri walas to the identified rehri zones were discussed with the representatives of various street vending organizations/unions so that they can live with dignity & earn their livelihood. During the meeting, VC, JDA Sh. Mubarak Singh also spoke about the govt policy that these Rehri zones have been created to decongest the traffic in Jammu city and provide a fixed place of business to the street vendors.

Commissioner, Jammu Municipal Corporation also assured the representatives of street vendors/hawkers union that the basic civic amenities like water, electricity, cleanliness etc. will be provided in the rehri zones & all their problems will be resolved on priority basis. The creation of rehri zones will also help in stepping towards achieving the goal of Swachh Jammu Mission.

The Vice Chairman Jammu Development Authority, Mubarak Singh (KAS), Sr. Supdt. of Police (Traffic) Udaya Bhaskar. B, Additional Deputy Commissioner Dr. Arun Manhas, (KAS), President, Chamber of Commerce & Industries Sh. Rakesh Gupta, President Trikuta Nagar Welfare Society Sh. Jammu Municipal Corporation as a part of country wide celebration of 1st Anniversary of Atal Mission for Rejuvenation and Urban Transformation (AMRUT) celebrated the event in JMC premises wherein, the activities carried out by Jammu Municipal Corporation under AMRUT were highlighted.

Jammu city is among the 500 cities selected under AMRUT mission wherein special funding for projects under Storm Water Drainage, Septage Management, Urban Transport, development of Green patches have been sanctioned during the mission period.

Jammu Municipal Corporation has been sanctioned projects amounting to Rs. 59.00 Cr. during the financial years 2015-16, which includes projects for drainage network in Jammu City, Development of Pedestrian walkway along the River Tawi from Peerkho to PHE office to facilitate the general public for walking, Development of green patches along both sides of Nallahs & canal at Gangyal (W.No. 56, 58) to provide recreation facility to the people of that locality and to regulate the Traffic in Jammu city , JMC hs planned to install new 34 Intelligent traffic signal lights under the scheme besides procurement of septage machinery for cleaning of big drains. During this financial year JMC will look up the upgradation of 8 big nallas for proper sewage

For the financial year 2016-17, projects amounting to Rs. 86.00 Cr. has been sent to the Govt. for approval which includes Multitier Parking at Panjtirthi, drainage and septage management, Dev. Of Green patches, procurement of machinery for septage etc.

A live presentation of the celebration event of 1<sup>st</sup> Anniversary of AMRUT organized at Pune, Maharastra at 4.00 pm onwards was also organized at Conference Hall of Jammu Municipal Corporation which was attended by Sh. R.S. Jamwal, Joint Commissioner (Adm), Sh. Neeraj Gupta, Chief Account Officer, Sh. Kushal Chand, Joint Commissioner (Works), Sh. Ranjit Singh, Secretary, Ms. Subha Mehta, Assistant Commissioner (Rev.), XEN(T), XEN(C), Dy. Director (Planning), Municipal staff and others stake holders of society were also present in the event.

These AMRUT projects when implemented in full will Rejuvenate the Jammu Town and will redressal the parking, drainage, traffic congestion problems besides improving the green patches in the Jammu City.

The AMRUT cities have also to undertake certain reforms initiatives for which citizens centric website of Jammu Municipal Corporation has been developed besides launch of mobile app of JMC from which citizens can lodge their complaints/grievances.

During last 4 months, 1014 complaints have been received online, out of which, 803 have been redressed and 211 are in process. E-News letter are also been published by JMC on monthly basis on the website for awareness of the general public.



## Jammu City stepping towards- Garbage to Gold

Under Swachh Bharat Mission, and clean India campaign Jammu Municipal Corporation started Solid & Liquid Resource Management (SLRM) training programme today from 27.06.2016 on the direction of Commissioner, Jammu Municipal Corporation Ms. Mandeep Kaur (IAS) and under the supervision of Assistant Commissioner (Revenue), Ms. Subah Mehta (KAS) (Nodal Officer). The training programme is conducted by Shri C. Srinivasan, Project consultant Indian Green Service resource person for SLRM project under the Ministry of urban development, Govt. of India at Gurjar Desh Charitable Trust, Channi Himmat near Jamkash Vehicleades. The project aims to make Jammu city neat and clean and garbage free. More than 800 trainees participated in the training programme and the trainees especially females showed keen interest and enthusiasm in making Swachh Jammu Mission a great success. On the first day 6 (Six) teams of trainees, zone wise were formed for Jammu city. The trainees will have 6 days class room training from 29th june to 4<sup>th</sup> July and from 5<sup>th</sup> July 9 days survey training of 71 wards of Jammu city will be launched for obtaining details of households and commercial establishments. #### JMC strikes on illegal reharies operating outside Rehri Zones.

During field visit by Ms. Mandeep Kaur, IAS, Municipal Commissioner and Sh. R.S. Jamwal, KAS, Joint Commissioner(A), the Enforcement wing of JMC led by Chief Enforcement Officer and Enforcement Officer conducted an exclusive anti encroachment drive at Akhnoor Road, Jammu.

During the drive the team seized the sizable no. of Rehris which were found stationary by encroaching upon road side and causing inconvenience to the pedestrians and hurdles in the smooth flow of vehicular traffic and all illegal Reharies plying / standing on road side at Akhnoor Road and surrounding area were seized and destroyed thereafter.

It is pertinent to mention that the Jammu Municipal Corporation has created the Rehri zones also for the Rehri Pullers including one near ITI College at Akhnoor Road, Jammu, but it was found that some of the Rehri pullers have abandoned the Rehri zone and were selling the articles on the road side. Besides, this the team also demolished 03 nos. of structures which have come up upon Govt. land in the said area by pressing the man and machinery into service and also removed other vendors who were selling their articles by encroaching upon road sides.

The Jammu Municipal Corporation appeals to the Rehri pullers to confine to the Rehri zone created for the Rehris and not to ply and keep the Rehri stationary on road side which besides inconvenience is also a source of obstruction and many times leads to traffic accidents.

About 37 Nos. of stray dogs was vaccinated against anti rabies/anti scabies treatment. JMC is going to organise such type of vaccinations in future also. JMC has already started the Sterilization /Immunization programme at Municipal Animal Care Centre, Roop Nagar Jammu. Till date about 1000 stray dogs are sterilized /immunized. Now, Approx. 10-15 dogs is sterilizing daily. JMC is going to speed up sterilization/anti rabies vaccination camps within JMC limits.

### JAMMU MUNICIPAL CORPORATION DEMOLISHES THE UNAUTHORIZED CONSTRUCTIONS

While further continuing and intensifying the drive against the unauthorized constructions and during the field visit by Ms. Mandeep Kaur IAS Commissioner Jammu Municipal Corporation and Sh. R.S Jamwal KAS Joint Commissioner (Adm.), the Enforcement Staff led by the Enforcement Officer demolished two no.s of ongoing construction works which were being raised by Sh. Kailash Choudhary and another by Sh. Vikas Gupta at East extension Trikuta Nagar Jammu.

The said constructions had been raised unauthorizedly and in violation of the building plan. The Jammu Municipal Corporation initiated the action under the provisions of J&K Control of Building Operation Act 1998.

The demolition operation has been conducted with the help of Police force from Trikuta Nagar/ Channi Himmat Police Station and Police force from Distt. Police Lines Jammu.

Further, the Jammu Municipal Corporation appeals to the General Public to refrain from making illegal constructions and get building plans whether commercial / residential approved from Jammu Municipal Corporation otherwise action as admissible under rules leading to demolition / sealing of the building will be taken against the violators.
