The Commissioner, JMC stated that JMC shall convene BOCA meetings regularly so that more and more building permission are granted under norms and pendency in this regard reduced.

The Commissioner, JMC also advised the general public to refrain from raising construction illegally/un-authorizedly and obtain proper building permission from Jammu Municipal Corporation before undertaking construction for their houses/commercial establishments, as such constructions are liable for legal action including sealing, demolition etc. He also advised the persons to whom building permission stands granted to approach JMC for clearing mulba at reasonable rates.

## Jammu Municipal Corporation has started home delivery of Birth & Death Certificates and approved building permission cases under <u>"Doorstep Governance" initiative.</u>

Jammu Municipal Corporation has started home delivery of Birth & Death Certificates and approved building permission cases under "Doorstep Governance" initiative. The online system is launched by Hon'ble Mayor, Sh. Chander Mohan Gupta & Hon'ble Deputy Mayor, Smt. Purnima Sharma in the presence of Ms. Avny Lavasa, Commissioner, Jammu Municipal Corporation. In view of the COVID-19 pandemic situation this system is introduced to avoid enormous gathering of general public and to promote contactless efficient public service delivery system. This initiative is being taken to promote Digital India and E—Governance initiative of Govt. of India. This is 1st such type of Government public service delivery initiative in the UT of Jammu and Kashmir. Only very few States/UT's are providing such type of Government services at doorstep. It will provide great relief to the general public and also eliminate the requirement to reach JMC office for such services. This is in-house technology developed by the Information Technology department of Jammu Municipal Corporation.

The requisite Fee is Rs 40 per birth/death certificate and Postal and Conveyance Charges Extra as per the below mentioned rates :

- 1. Within JMC Limits Rs 50/-
- 2. Outside JMC Limits but within district Rs 100/-
- 3. Outside District/Division but within JK UT- Rs 150/-.
- 4. Outside JK UT Rs. 200/-.

For building permission cases the fee is as per the approved plan and the Postal and Conveyance Charges are Rs 150 within JK UT and Rs 250 outside JK UT.



In this system, SMS, E-mail & online payment gateway integration has been done and all the payments shall be received online through secure mechanism directly into the JMC bank account. The online receipt and the payment successful acknowledgement shall be provided to the applicant online.

For Doorstep Birth/Death Certificate and Building permission, public has to visit <u>www.jmcjammu.org</u> then has to use Menu Option "E-Governance > Doorstep Governance > Apply online for birth/death certificate" and "E-Governance > Online Building Permission > Register for building permission" respectively.

In case of Birth/Death, applicant shall be communicated through e-mail : <u>sahuliatjmc@gmail.com</u> for available record verification. Self attested documents shall be asked from the applicant in case of alteration/corrections are required in the available record. Then documents verification and alteration/modifications of the available record done by JMC and an online payment fee link sent to the registered e-mail & mobile number of the applicant. On successful online fee payment, confirmation sent by JMC to the applicant and finally Birth/Death Certificate shall be dispatched through speed post to the applicant's registered address.

In case of building permission cases after the approval of building permission cases by BOCA, an online payment fee link shall be sent to the registered email & mobile number of the applicant. On successful online fee payment, confirmation sent by JMC to the applicant and finally building permission shall be dispatched through speed post to the applicant's registered address.











## **Procurement of Cattle catcher vehicles**

With addition of these newly procured cattle catcher vehicles in Veterinary wing of JMC, the menace of stray animals can effectively be contained in Jammu City, besides time bound rescuing the sick and injured stray animals within the limits of JMC.

On the directions of Commissioner Jammu Municipal Corporation Ms. Avny Lavasa (IAS) and under overall supervision of Secretary, JMC, Ms. Tinna Mahajan (KAS), a team of JMC conduced a drive whereunder illegal hoardings and banners from various main roads and on the rooftop of various buildings of city has been removed and also cleared 09 huge hoarding structures mounted on the roof as well as ground within the premises of Press Club Jammu. During the drive, JMC removed all the illegal hoardings which had been in place since years. The team removed 9 hoardings of size  $30 \times 15 \& 20 \times 10$ . All these hoardings were installed without the permission of JMC

The installation of such illegal hoardings, signboards, posters, banners & bill boards deface the property, buildings and walls of the city and are also constant threat to pedestrians and traffic safety. As per the advertisement, "Whenever any advertisement is displayed in contravention of section 116 of the J&K Municipal Act 2000, the same is actionable as per provisions of section 119 and 384 of the J&K Municipal Act 2000 with fine which may extent to Rs. 5000/- and with a further fine which may extend to Rs. 1000/- for every day during which the offence continues."

The Jammu Municipal Corporation appeals to the general public to remove all such hoardings, sign boards, posters, banners, bill boards & pole kiosks installed illegally failing which action will be initiated against the offenders and further contravention of the same shall attract penalty against such defaulters.

#### Hon'ble Mayor Sh. Chander Mohan Gupta, JMC conducted a meeting regarding Strengthening the working of Jammu Municipal Corporation

Mayor, Jammu Municipal Corporation, Sh.Chander Mohan Gupta today on 25-06-2020 chaired a meeting in the conference hall of JMC along with Dy. Mayor, Adv. Purnima Sharma, Principal Secretary to the Govt. H&UDD Sh. Dheeraj Gupta and Commissioner JMC, Ms. Avny lavasa. Chairpersons of Standing Committee(s) Sh. Suraj Parkash, Sh. Baldev Singh and Sh. Jeet Angral also attended the meeting.

During the meeting ,Mayor, JMC submitted a memorandum to the Principal Secretary to the Govt., H&UDD and appraised him that Jammu Municipal Corporation with elected representatives has come into existence in Oct 2018. The area of JMC prior to coming into existence of the elected body has been extended by nearly 70 % and presently there are 75 wards.

In the meeting a threadbare discussion on the redressal of burning issues of Jammu Municipal Corporation was discussed like immediate implementation of 74th amendment, to ease out the process of granting building permission to the general public, Smart city project to the Commissioner JMC, reorganization of Jammu Municipal Corporation, Special grants for development activities to be sanctioned especially for extended and newly included wards in Jammu Municipal Corporation as the people residing in these wards are suffering a lot due to lack of development works. SDRF Funds may also be released for continuing development activities in various wards of Jammu City, Work on major projects of Jammu City such as Jamboo Zoo, Gandola Project, Artificial Lake, Multistory Parking's etc to be speeded up, separate wing of Solid Waste Management System with experienced officers / officials in Solid Waste Management may be established in JMC, strengthening of enforcement wing of JMC and experienced to be hired for executing Major Development Projects of Jammu Municipal Corporation, necessary measures be taken for change of land use at Nagrotra (earlier meant for Slaughter Houses) for establishment of Amusement / Recreation Parks by the Tourism Department.





Principal Secretary assured the Jammu Municipal Corporation that every possible steps be taken to strengthen the working of Jammu Municipal Corporation.
