He further added that JMC shall prepare a proposal for the construction of horse equines and cattle shed over the said land at Bandurakh. He issued on spot directions to the Engineering Wing to expedite the construction work and also apprise the bottlenecks in executing the said works to the authorities so that the same can be removed and desired results could be achieved. He further added that these are the priorites of JMC and need is to focus on it so that all the proposals are implemented in a better and effective way.

The surprise drive started from B.C Road, Amphalla, Newplot, Janipur, Roop Nagar, Bantalab, CPO Chowk Panjirthi, etc.

During the drive, various meat shops were checked and about 50 kg of substandard meat was seized and later on disposed of properly along with a fine to the tune of Rs. 11000/- was also levied to the meat sellers selling unstamped meat and not following the guidelines.

Hon'ble Mayor has appealed to all the shopkeepers dealing with meat/chicken products to maintain hygienic environment in and around their shops and make availability of good quality meat to the consumers. He also appealed to install the black/red colour glasses in their shops and do not hang the meat outside their shops. Further he made the meat sellers aware of the standard operating procedure while carrying out their business especially in view of ensuing COVID-19. It was impressed upon all the meat sellers to ensure social distancing maintain personal hygiene like wearing Masks, head caps, aprons and gloves and frequent using of hand sanitizers. MVO said that such surprise drives will continue in near future as well to ensure that the consumers can get healthy, wholesome and diseased free meat at any cost.

<u>Press Release for implementation of 74th Amendment in Union</u> <u>Territory of Jammu & Kashmir.</u>

Jammu Municipal Corporation launched a drive against the advertisement displayed illegally in the different areas falling within the limits of Jammu Municipal Corporation.

On the instructions of Ms. Avny Lavasa, IAS Commissioner, Jammu Municipal Corporation & under the supervision of Sh. Ashish Kumar Gupta, Joint Commissioner (A) the field staff led by Ms. Tinna Mahajan, Secretary launched a drive vigorously against the advertisement displayed illegally in the different areas falling within the limits of Jammu Municipal Corporation.

In the last few days the drive has been conducted in various areas of Jammu city i.e. Janipur, Bantalab, Barnai, Roop Nagar, Dogra Hall, New Plot, Kacchi Chawani, Panjtirthi, Parade, Exchange road, Residency Road, Rehari Colony, Bhagwati Nagar, Amphalla, Akhnoor road, Talab Tillo, Bohri, Paloura, Bakshi Nagar, Nanak Nagar, Gandhi Nagar, Sainik Colony & Jewel area. However, 435 nos of illegal hoardings and in total five tata mobile (207) of advertisement material was lifted from these areas & the drive is still continuing on daily basis.

The installation of such illegal hoardings, signboards, posters, banners & bill boards deface the property, buildings and walls of the city and are also constant threat to pedestrians and traffic safety. As per the advertisement, "Whenever any advertisement is displayed in contravention of section 116 of the J&K Municipal Act 2000, the same is actionable as per provisions of section 119 and 384 of the J&K Municipal Act 2000 with fine which may extent to Rs. 5000/- and with a further fine which may extend to Rs. 1000/- for every day during which the offence continues."

The Jammu Municipal Corporation appeals to the general public to remove all such hoardings, sign boards, posters, banners, bill boards & pole kiosks installed illegally failing which action will be initiated against the offenders and further contravention of the same shall attract penalty against such defaulters.
