

Joint anti encroachment drive by Jammu Municipal Corporation & Police

On the instructions of Commissioner, Jammu Municipal Corporation Mr. Ramesh Kumar (IAS), a joint anti-encroachment drive was conducted by Jammu Municipal Corporation, Traffic and executive police under the supervision of Joint Commissioner (A), JMC, Sh. Rajesh Sharma (KAS) and Assistant Commissioner (Rev.), JMC, Mrs. Vinakshi Koul (KAS).

During the drive Chief Enforcement Officer, Sh. Rajesh Gupta, Revenue Officers, Sh. Parmod Kumar, Sh. Ashwani Sudan, Sh. Parveen Gupta and Sh. Sunil Gupta of JMC, Enforcement staff of JMC & Police personals from concerned police station also accompanied the drive.

The drive was conducted in compliance of the Hon'ble High Court directions as well regarding removal of unauthorized rehries or the encroachments on the roads in the areas from City Chowk to Central Basic High School Purani Mandi Jammu.

During the drive, the team of Jammu Municipal Corporation removed encroachments and cleared the footpaths and pavements. The team seized 2 illegal rehries plying without licence from these areas and seized 4 trucks of material displayed by the shopkeepers/phariwalas in front of their shops and footpaths causing traffic congestion and free flow of pedestrians.

During the drive, the Joint Commissioner (A), Jammu Municipal Corporation appealed to the shopkeepers to keep their goods within their establishments to avoid penal action against them and directed the street vendors/rehriwala's to ply their rehries only in the rehri zones established by Jammu Municipal Corporation.

Mr. Ramesh Kumar (IAS), Commissioner Jammu Municipal Corporation conducted an extensive tour of Jammu City and inspected the ongoing Projects under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) as well as developmental works of the Corporation being executed at different sites viz. MAM Stadium, Drainage Project from Pawan Ice Cream to AG Office, Up-gradation/construction of drainage from Kamla Place on words, construction of drainage from Top Sherkhania, Sarika Vihar etc. Funds under AMRUT meant for undertaking construction of lanes, drains, deep drains, nallahs, developmental of green spaces and parking etc. so that there can be no obstruction in free flow of water during monsoon, providing of parking facilities to the citizens as well as development of green spaces to give neat and green look to the city and also to create healthy atmosphere. He gave on spot directions to the concerned officers for completion of ongoing developmental works in a time bound manner and also directed them to directly approach him in case they face any difficult in respect of ongoing development works.

The Commissioner further stressed upon the completion of the projects being undertaken by JMC under AMRUT, as these projects will play a vital role in making Jammu as one of the Smart City.

Commissioner, JMC took review of preparedness of Swachh Survekshan-2018.

Sh. Ramesh Kumar (IAS), Commissioner, Jammu Municipal Corporation took a review of progress of Swachhata and preparedness of Swachh Survekshan-2018 during which he issued instructions to the concerned Officer for taking steps for installation of composting machines in bulk generator establishments like Hotels, Banquet and Fruit/Vegetable markets which would help in minimizing the accumulation of waste and added that compost so generated will also help the persons who associated with agriculture line.

He directed the concerned Officer to utilize the men and machinery available with Corporation for maintaining proper sanitation conditions within the limits of Jammu Municipal Corporation. He added that some wards shall be selected as model wards for ensuring better scientific cleaning and its disposal including transportation after proper segregation. He also directed the Health Officer to maintain proper attendance of sanitation staff so that there can be no laxity in providing proper sanitation to the inhabitants of the City.

He further stressed upon all the Officers to take sanitation of the City as a challenge and come with a road map on their level so that same is deliberated and action is taken on the actionable points.

He appealed the general public through this medium to extend their helping hand to Jammu Municipal Corporation in maintaining the proper sanitation and also to achieve the goal of Swachh Bharat Mission and Smart City.

JMC demolishes unauthorized construction

On the direction of Sh. Ramesh Kumar (IAS) , Commissioner Jammu Municipal Corporation, Sh. Rajesh Sharma (KAS), Joint Commissioner (A) JMC, led Enforcement Staff along with Chief Enforcement Officer and Enforcement Officer and undertook an extensive drive against the unauthorized constructions raised unauthorizedly and in violation of provisions of J&K control of Building operation act 1988.

During the drive 4 Number of Shops at Friends Colony Trikuta Nagar Ext.. Near canal were demolished and 4 numbers of iron rolling shutters fixed there were also demolished by pressing men and machinery into service which were being extended towards road side without the permission of JMC.

The demolition drive has been conducted with the co-operation and assistance of Police force led by station house Officer , Channi Himmat Police station Jammu.

The Jammu Municipal Corporation Appeals to the General Public to refrain from raising unauthorized construction/s failing which the demolition/sealing of the unauthorized structure will take place. Further it is also requested not to dump the building metal on road/lane side which causes obstruction to the public and also hindrance in the smooth flow of vehicular traffic.

Commissioner, JMC reviews arrangements for Eid-i-ul-Nabi

A meeting under the Chairmanship of Sh. Ramesh Kumar (IAS), Commissioner, Jammu Municipal Corporation was convened to review the arrangements for ensuing **Eid-i-Milad-ul-Nabi**. Directions were issued to all the concerned Officers to ensure deployment of additional sanitation staff for improving the sanitation of different areas especially in the areas around the mosques and on the roads leading to them.
