**Commissioner, JMC alongwith other staff visited areas viz. Peerkho, Circular Road, Panjtirthi Parking, Ambphalla, Saraswati Vihar etc.**

Dr. Manmohan Singh (KAS), Commissioner, Jammu Municipal Corporation visited areas viz. Peerkho, Circular Road, Panjtirthi Parking, Ambphalla, Saraswati Vihar, Toph Sherkhania, Kamla Palace Road, Canal Road, Nai Basti, Digiana Jeevan Nagar, etc. and took stock of developmental works which are undergoing under AMRUT (Atal Mission for Rejuvenation and Urban Transformation) Scheme amounting to Rs. 14.00 crores and also visited the site at Circular Road which has been proposed for construction of multi-tier parking for an amount of Rs. 15.00 crores. Funds under AMRUT meant for undertaking construction of lanes, drains, deep drains, nallahs, developmental of green spaces and parking etc. so that there can be no obstruction in free flow of water during monsoon, providing of parking facilities to the citizens as well as development of green spaces to give neat and green look to the city and also to create healthy atmosphere. He also inspected the ongoing works of Bus Queue Shelters at Ambphalla, B.C. Road, pedestrian walkway along river Tawi from Peerkho to PHE Station, Jammu as well as took stock of nallah flowing from Karan Nagar to Shunktala Theatre. He gave on spot directions to the concerned officers for completion of ongoing developmental works in a time bound manner and also directed them to directly approach him in case they face any difficult in respect of on going development works.

### **Commissioner, JMC alongwith other staff visited areas viz Tawi Vihar & Asrarabad.**

On the direction of Commissioner, Jammu Municipal Corporation, Dr. Manmohan Singh (KAS) and under the supervision of Sh. R.S. Jamwal (KAS), Joint Commissioner (A), JMC and accompanied by Imran Malik, Liasion Officer, Chief Minister Grievance Cell, an extensive tour was launched in Ward No. 71 which comprising of two areas viz. Tawi Vihar which is a well planned colony and other is Asrarabad which is unplanned colony and lacks basic amenities like sanitation, development of roads, lanes/drains. The area came under the jurisdiction of Jammu Municipal Corporation in the 2008 being the extension of Ward No 71. The residents were approaching time and again in JMC for providing them the basic facilities so that their sufferings can be mitigated. Keeping in view their constant demands, JMC conducted an extensive tour during which the concerned officers took stock of their grievances and assured them that authorities will put its every possible efforts to redress their genuine demands by deploying men and machinery and well construction of lanes and drains.

During the course of tour, on spot directions were issued to the concerned officers to prepare proper outlay for installing dustbins, street lights, construction of lanes/drains so that the residents of Asrarabad could be eased of their present problems which they are facing a lot due to lack of basic facilities. It was also observed that large heaps of garbage in the area, the Health& Sanitation Wing of JMC was directed to lift the garbage and Chief Transport Officer, JMC was also directed to install dustbins at the most vulnerable points. Joint Commissioner (A) further directed the concerned officers to publish a notice in the newspapers with respect to the open plots which have been converted into dumping points by the inhabitants and in case the owners of the such plots fails to do so in that case JMC will take action in respect of the same.

People gathered during the tour appreciated the role of Jammu Municipal Corporation and assured that they shall extend their full cooperation to JMC in maintaining their surroundings neat and clean.
