JMC convenes meeting with regard to introduction of POS Machines for revenue collection and File Tracking System (FTS)

A meeting with regard to introduction of digital initiatives viz. online File Tracking System and POS machines for revenue collection, user charges etc. was held under the chairmanship of Sh. Pankaj Magotra (KAS), Commissioner, Jammu Municipal Corporation. During the course of meeting, the Commissioner stated that JMC shall develop a Mobile Application for data entry in respect of residential and commercial establishments so that a unique customer Id of each household will be created and the same shall be used while paying different kinds of taxes/rents related to JMC. He further emphasized for taking measures to enhance the revenue collection of JMC by way of digital mediums.

He gave directions to all the Sectional Heads of JMC for initiating the process for implementation of online File Tracking System in JMC within a week's time, as the online File Tacking System will help to track the files instantly for speedy disposal of the matters. The Commissioner, JMC further added that Digital Data Entry mobile APP will also help to provide digital database alongwith GIS location and image of the residential and commercial establishments. JMC will start revenue collection of JMC assets like flats, shops, godowns, user charges etc through POS Machines and provide the computerized receipts to the consumers on the spot and the MIS of the same will be provided online to the higher authorities.

Besides, Commissioner, JMC, Joint Commissioner (A), Secretary, Asstt. Commissioner (Rev.), Chief Accounts officer, Health Officer, MVO, CTO, Revenue Officers and Informatics Officer were also participated in the meeting.

JAMMU MUNICIPAL CORPORATION DEMOLISHES THE UNAUTHORIZED CONSTRUCTIONS

While further continuing and intensifying the drive against the unauthorized constructions, on the directions of Pankaj Magotra (KAS), Commissioner, Jammu Municipal Corporation, the Enforcement Staff led by the Chief Enforcement Officer under overall supervision of Pardeep Singh (KAS), Joint Commissioner (A), Jammu Municipal Corporation demolished the shuttering of ongoing illegal construction work at Last morh Gandhi Nagar area.

The said constructions had been raised unauthorizedly and in violation of the building plan. The Jammu Municipal Corporation initiated the action under the provisions of J&K Control of Building Operation Act 1998.

Further, Ms Sunaina Sharma, (KAS) Secretary Jammu Municipal Corporation supervised anti encroachment drive conducted in below Gumat, Indra Chowk, Bus Stand, Jewel and residency Road. The articles which were placed outside the shops and establishment of the shopkeepers were removed, 5 illegal rehries were lifted from Bus stand areas which was creating traffic hazards. Shopkeepers were instructed not to display articles outside the shutters lines. Number of footpaths was also cleared at below Gumat and Indra chowk.

The Jammu Municipal Corporation appeals to the General Public to refrain from making illegal constructions and get building plans whether commercial / residential approved from Jammu Municipal Corporation otherwise action as admissible under rules leading to demolition / sealing of the building will be taken against the violators Shopkeepers are also appealed to keep their material inside the shutter line to avoid any sort of encroachment.

JMC convenes Building Operation Controlling Authority Meeting

The Building Operation Controlling Authority (BOCA) meeting was held on 02/02/2019 under the chairmanship of Sh. Pankaj Magotra (KAS), Commissioner, Jammu Municipal Corporation, wherein the representatives of the line departments also participated. During the course of meeting 42 residential building permission cases were approved. The cases cleared in the BOCA would generate revenue for the Jammu Municipal Corporation apart from bringing succor to the applicants who had long awaited the said permission. The Commissioner, JMC stated that JMC shall convene BOCA meetings regularly so that more and more building permission are granted under norms and pendency in this regard reduced.

The Commissioner, JMC also advised the general public to refrain from raising construction illegally/un-authorizedly and obtain proper building permission from Jammu Municipal Corporation before undertaking construction for their houses/commercial establishments, as such constructions are liable for legal action including sealing, demolition etc. He also advised the persons to whom building permission stands granted to approach JMC for clearing mulba at reasonable rates.

Hon'ble Mayor, Jammu Municipal Corporation presided the meeting. Joint Commissioner (A) JMC, Assistant Commissioner (Nazool) Jammu, Sr. Town Planner, Town Planning Organization, Sr. Town Planner, JMC AEE, Inspection Div. PDD, Jammu, AEE (Tech. Officer) Sewerage & Drainage, Jammu, AEE (Tech. Officer) PHE City Div. II, Jammu, AE PHE City Div. I, Jammu, AE PHE Rural, Jammu also attended the meeting.

Principal Secretary, Housing & Urban Development Department conducted tour of different urban developmental projects.

Principal Secretary, Housing & Urban Development, Sh. Dheeraj Gupta (IAS) accompanied by Deputy Commissioner Jammu, Sh. Ramesh Kumar (IAS), Commissioner, Jammu Municipal Corporation, Sh. Pankaj Magotra (KAS), Vice Chairman JDA Sh. Pawan Singh Rathore (KAS), MD Housing Board, Sh. R.K. Katoch (KAS) & Chief Engineer PDD, Sh. Sudhir Gupta today conducted an extensive familiarization tour of the major upcoming urban development projects which shall soon make marked difference in the urban landscape of Jammu City and also took stock of the pace of progress of these works.

During the review of Multi-Level Car Parking Shopping Complex at General Bus Stand, Jammu he was briefed by the Vice Chairman JDA that the work of the said six-storeyed complex catering to terminal of 80 buses, parking of 1312 cars &177 scooters with shopping mall in top two floors and 167 shops at the ground floor was started in October 2016 and is targeted to be completed substantially by 30th April 2019 as per the crash programme submitted by the contractor M/s SPCPL.

During the inspection, Sh. Dheeraj Gupta directed the officers of PDD to complete the 6.3MVA 33/11KV dedicated receiving station by 30.04.2019 so as to make the MLCP complex fully functional. He was further apprised by the Vice Chairman about the connectivity through proposed elevated corridor from the Super Speciality Hospital across B.C Road & direct access to the mall through Foot Over Bridge from the Hari Market side to the complex .

In view of the targeted date of 30.04.2019 he passed instructions to the engineers and contractors to accelerate pace of work and chalk out a plan for facility management so as to ensure timely completion of the project and the public is benefited at the earliest.

He further directed the staff of JDA to prepare a Detailed Project Report for construction of Multi-level complex with Multiplex halls as Phase II, over the area of existing Bus Stand in view of the condition of the existing building of Bus Stand.



During his visit to Muthi, progress of 72 No. under construction flats in (Phase-I) being constructed at an estimated cost of Rs.35.31 Crore was reviewed, and he expressed his displeasure on delay in the completion and emphasized to complete the said flats in all respects at the earliest. He was also apprised regarding construction of upcoming 144 number flats in Phase-II at an estimated cost of Rs.79.66 Crore, the work of which stands allotted to a Delhi based firm on EPC mode. He showed his concern regarding non provision of basement parking in the said flats. He gave on spot directions to the Commissioner, Jammu Municipal Corporation and Vice Chairman, Jammu Development Authority to make it obligatory to keep provisions of basement parking in the upcoming projects.

The Principal/Secretary also inspected Commercial Shopping Complex at Muthi being constructed at an estimated cost of Rs.10.17 Crore and was satisfied with the progress of the project. The Principal/Secretary also visited the working women hostel site at Boria Basti which is being constructed at an estimated cost of Rs. 529 lacs and was satisfied with the progress of the work and directed to outsource for its operation and maintenance after its completion. He also inspected Night Shelter building at Boria Basti constructed at an estimated cost of Rs. 198 lacs.

The Principal Secretary was also briefed about the upcoming Tawi River Front development project being constructed taken by the Jammu Development Authority on both sides of river Tawi between Bikram Chowk Tawi bridge to 4th Tawi bridge. This project overlooking the proposed Tawi Barrage envisages development of Tawi embankment by way of diaphragm wall and retaining walls. The retrieve land shall be utilized for development of green strips, amusement parks and some portion shall also be commercially developed to recover the cost of the project. JDA is taking up 1.5 km project on pilot basis during the current year.



At the Bhagwati Nagar site, the Principal Secretary, H&UDD was informed that three 67 MLD total Capacity Sewerage Treatment Plants are being constructed in the areas out of which 30 MLD capacity plant constructed by ERA has started operations and is presently being maintained by UEED. Directions were issued by the Principal Secretary to the General manager, NBCC to complete network, house connections and 27 MLD capacity sewerage treatment plant of the sewer project entrusted to NBCC by August, 2019 and in this regard directed him to submit Bar Chart for completion of the balance work on fortnightly basis and submit the detail report on the project within a week's time. Chief Engineer, UEED was directed to submit a complete action plan for smooth transfer, operation and maintenance of sewerage projects which are going to be completed in the current year by various executing agencies. While inspecting the STP Laboratory, the Executive Engineer was directed to submit a proposal for upgradation of the laboratory so that it becomes compliant to latest industry norms..

The Principal Secretary also visited the Intelligent Traffic Management sytem Control Room established at Gulshan Ground, Jammu and gave useful suggestions for improving the present traffic light management and directed the Commissioner, JMC to expedite the process for introducing traffic violation detection system on these intersections to enable e-challaning.

Mayor, JMC directed the concerned authorities to speed up process of recruitment of safaikaramcharies to improve the sanitation work of every ward. He stressed upon the authorities to start the Bio-Metric attendance of sanitation staff. Mayor issued instructions to the concerned authorities that JMC parks should be maintained at the earliest by constituting two teams of gardeners/malies. He also issued instructions for engagement of linemen and helpers in Electric section through NGO to achieve the goal of providing the street light facilities to the general public at large. During the meeting the Mayor also issued directions to the concerned authorities to speed up the process of door to door collection, night scavenging, purchasing of wooden wheel barrows, auto for lifting of segregated waste from the household, lifting of stray animals. He emphasized that building permission may be given in one go and the cases pending for compounding shall be considered on priority basis so that general public may not suffer. Time frame for completion of development works also fixed and the mulba remained at the site after completion of construction / development works shall be removed by the contractor at its own and for the same NOC from the concerned councillor shall also be taken for release of the payment.



The members also raised the issue of street lights, recruitment of Safaikaramcharies at the earliest to meet up the problem of sanitation and providing of vehicles for lifting of garbage. They also demanded speedy disposal of building permission cases.

Commissioner, JMC assured the Chair that every possible steps shall be taken for better functioning of Jammu Municipal Corporation.

Hon'ble Mayor assured all the members that necessary steps be taken for smooth functioning of the corporation and speedy disposal of the grievances of the general public. He also thanked the entire team of JMC for showing their keen interest in resolving the issues.

Joint Commissioner (A) pointed out regarding the various sanitation issues raised by the Hon'ble Councillors and directed the staff of sanitation wing to resolve the issues in consultation with the Hon'ble Councillors.

It has been also pointed out that the graph of user charges is also on very lower side. He issued directions to gear up the collection of user charges and achieve the desired targets by the ending March 2019.

The issue of dumping of Mulba / building material has been also pin pointed by the chair and it has been desired that challan to be served to the defaulters who have dumped the material creating insanitary conditions and also inconvenience to the public in general.

The chair also pointed out that the sewerage manholes within the limits of JMC found overflowing at various locations, thus creating insanitary conditions and inconvenience also to the public in general. The field staff has been directed to report immediately so that the matter could be taken with the concerned departments for rectification.

It has been also pointed out that despite a ban on use of polythene, the polythene is being sold in the markets. The directions has been issued to seize the polythene and imposed penalty also on the defaulters.

The other who were present in the meeting Assistant Sanitation Officer, Sanitary Inspectors and Sanitary Supervisors.

The meeting ended with the vote of thanks to the chair.

The lecture were delivered by Mr. Jorawar singh, Associated Representative from JMC and Dr. Zafar Iqbal, Nodal Officer Solid Waste Management, JMC regarding the topic Solid Waste Management enhancing the Mission of Swachh Bharat Abhiyan by Hon'ble Prime Minister of India. Chairman SWM, Committee, JMC also delivered the lecture regarding awareness of SBM programme.

The students were told that the Municipal waste is comprised of organic/inorganic materials. From organic material Methane CH4 is prepared after the process of fermentation which may be completed within few days and from inorganic material particular from plastic, plastic oil, kerosene oil is prepared.

Plastic oil is used in place of Bitumen to save fossil, fuel and from kerosene oil other petroleum products are prepared. A rally was taken around the institution and students were told to put the organic /inorganic material in separate dustbins. This activity helped students to learn about segregation of material for the process of Reduce, Reuse, Recycle, Recovery etc.
