The Commissioner, JMC further appealed to the residents/shopkeepers of the above said areas as well as general public to cooperate with Jammu Municipal Corporation and use identified places for disposal of garbage. She also stressed to avoid use of polythene to the extent possible which is the major cause of blockage of drains and nallahs. She stressed for putting every possible efforts in achieving the goal of making Jammu City Clean & Green and aim of Swachh Bharat Mission and added that such types of special drives shall continue in future to cover every nook and corner of the city from sanitation point of view.







ABC/ ARV Monitoring Committee Meeting

Commissioner, JMC, Avny Lavasa, today on 4th Feb 2022 chaired the 3rd ABC/ ARV Monitoring Committee Meeting in the Conference Hall of JMC to review the current status of ongoing ABC/ ARV Programme within JMC limits. The meeting was attended by the members of ABC monitoring Committee viz. Sh. Anil Kumar Masson, Hon'ble Councilor W.No.10, Dr. Sushil Kumar Sharma, MVO, JMC, Dr. Indu Bhushan, VAS, MACC Roop Nagar, Mrs. Devinder Kour Madaan, Chairperson, SAVE (NGO) and Mrs. Namrata Hakhoo, Founder/ Chairperson, Hakhoo Street Animals Foundation Trust (Regd.). During the meeting, threadbare discussions were held on various aspects of ABC/ ARV Programme being run by JMC and various decisions were taken for better progress of ongoing ABC/ ARV programme at MACC Roop Nagar, Jammu. MVO, JMC Dr. Sushil Kumar Sharma presented the current status of ABC/ ARV Programme before the committee members that since the award of contract to the implementing agency i.e. Friendicoes-SECA w.e.f 01-04-21 to 31-01-2022, 5239 stray dogs have been sterilized/ vaccinated with ward wise/ complaint basis catching and all sterilized/ vaccinated dogs are relocated in the same area from where they were caught as per the guidelines of the ABC (Dogs) Rules, 2001, promulgated under the Prevention of Cruelty to Animal Act, 1960. In the meeting, it was decided that the local Animal Welfare organizations in collaboration with JMC shall contribute in counseling of general public through conducting Awareness camps about improving human behavior towards community dogs and should make diligent efforts to sensitize, inform and educate the community about the effectiveness of ABC/ ARV Programme in helping to reduce dog population as well as in eradicating rabies. It was also decided that ward wise catching shall be done so that no area will be left uncovered for sterilization and vaccinations within JMC limits.



Commissioner, JMC stressed for better coordination among the JMC authorities, Animal activists/ Volunteers and Animal Welfare organizations operating in the area for making this programme a success, so that dog population can be controlled in a time bound manner as prescribed by the Animal Welfare Board of India. Meeting ended with a vote of thanks to the Chair.

Special Session of the General House was organized in the Council Hall of Jammu Municipal Corporation

Today on 07/02/2022, a Special Session of the General House was organized in the Council Hall of Jammu Municipal Corporation. The Special Session was chaired by the Mayor of JMC, Sh. Chander Mohan Gupta, Deputy Mayor, Adv. Purnima Sharma, Commissioner JMC, Miss Avny Lavasa (IAS), Chairpersons of the Standing Committee(s), Councillors and Senior Officers of JMC also remained present in the Special Session of the General House of Corporation.

In the previous Special Session of the House of Corporation which was held on 20/12/2021 in which a number of suggestions were made and a threadbare discussions over the suggestions made by Mayor, Dy. Mayor, Chairpersons of the Standing Committee(s) and Councillors. Thereafter, a Committee was constituted comprising of Deputy Mayor, Adv. Purnima Sharma as Chairperson of the Committee, Hon'ble Councillors Sh. Rajinder Sharma, Sh. Pawan Singh, Sh. Suneet Kumar Raina and Officers of JMC and other line Departments i.e. Chief Town Planner, JMC, DLR, JMC, Chief Architect, J&K (UT), Architect (Technical Officer to Director, Local Bodies) for submission of suggestions and observations/recommendations for amendments in the Unified Building Bye-Laws- 2021.

The Committee takes suggestions of the Councillors regarding amendments to be made in the Unified Building Bye-Law- 2021 and submitted their observations/recommendations in the Special Session held on 07/02/2022. The Committee suggested a number of suggestions/recommendations like:

- 1. Value Capture Fund to be deferred.
- 2. Building permission of constructions where ground floor is existing at site in violation which was already passed by the House of Corporation.
- 3. Lane Width relaxation for built-up contructions.
- 4. Approval of Colonies with relaxation if the existing approach road width is less than required upto 1 Hectare.



- 5. Stilt floors shall be allowed for parking. Shall be on all roads where construction is allowed.
- 6. The Building fee should not be charged for religious buildings and orphanages.
- 7. Labour Cess collected by JMC on behalf of Labour Department to be charged by Labour Department at their own.
- 8. Ramps should not be allowed beyond drains along the plot boundary. In case there is no drain, ramp should not exceed beyond 0.75 mtr. from plot edge.

In the Special Session, a number of decisions were taken including the extension of the period of the Committee constituted for suggestions/amendments in the Unified Building Bye-Laws- 2021 for another three months so that the Committee can take more suggestions from the Councillors of each ward and submit their recommendations to the House for its approval by which JMC can provide better facilities to the General Public at large.

Mayor, JMC assured all the Councillors and Jammuites that all necessary steps shall be taken for the smooth functioning of Corporation and speedy disposal of grievances of the general public.

JMC carries out anti-encroachment drive in City

The Jammu Municipal Corporation (JMC) on Wednesday conducted antiencroachment drive in city areas and dismantled several pavements raised by shopkeepers to ensure free movement of vehicles and pedestrians. The drive was conducted on the instructions of Jammu Municipal Corporation (JMC) Commissioner with support of Enforcement staff of the Corporation. These obstructions are the major cause of accidents during the movement of vehicular traffic.

JMC STOPS ILLEGAL CONSTRUCTIONS AT SUNJWAN

The Commissioner, JMC further appeal to the general public to refrain from raising illegal constructions and get building plans approved for commercial and residential purpose and raise building according to approved building plan, failing which action as warranted under Jammu and Kashmir Control of Building Operation Act,1988 and other Acts in vogue viz.,Jammu and Kashmir, Municipal Corporation Act,2000 will be taken against the violators including sealing and demolition of the illegal structures. She added that JMC has introduced Online Building Permission Systems (OBPS) which is very user friendly through which the residents can get their building plans approved within the shortest possible time at their door steps. Even if they don't require to come to office, everything is available online.

Jammu Municipal Corporation conducts a surprise drives in different areas of Jammu City on the eve of Maha Shivratri.

On the directions of Commissioner, JMC, Ms. Avny Lavasa, Municipal Veterinary Officer, Dr. Sushil Kumar Sharma and Assistant Commissioner, Food Safety Dr. Parvesh Kumar along with team of Doctors deputed by Sheep Husbandry Department conducted surprise joint drives on the eve of Maha Shivratri in different areas of Jammu City to ensure the sale of wholesome and good quality meat and meat byproducts to the consumers. The surprise drive started from Narwal, Gandhi Nagar, Gangyal, Satwari, Talab Tillo, Bohri, Muthi, Bantalab, Paloura, Janipur, Amphalla, CPO chowk, etc.

During the drive, various meat shops, chicken shops & fish mongers were inspected and about 25 Kg of substandard meat was seized and later on disposed of properly along with a fine to the tune of Rs. 42,000/- was also imposed to the meat sellers for selling unstamped & substandard meat. 20 Food business operators were also booked under FSSAI Act 2006

Notices have been served to various meat shops owners to install the black/red colour glasses in their shops and do not hang the meat outside their shops. Meat & chicken shop owners were instructed to keep separate bins with black polythene to collect the daily waste generated on account of refused/inedible meat & chicken parts for further proper disposal through JMC vehicles.

Municipal Veterinary Officer and Asstt. Commissioner, Food Safety appealed to all the shopkeepers dealing with meat/chicken products to maintain hygienic environment in and around their shops and adhere with the various provisions of Food Safety Act, 2006 and other directions & guidelines issued by the JMC from time to time so that good quality of meat shall reach to the consumers.
